FINAL CONSENT ORDER ON PLAINTIFF'S PETITION TO MODIFY VISITATION AND DEFENDANT'S COUNTERCLAIM FOR CHANGE OF CUSTODY

The above styled-matter having been set for mediation on November 9, 2010, at 1:30 p.m at the Cobb County ADR office, the parties appeared represented by their counsel, Blake Dexter Halberg appeared on behalf of the Plaintiff, Gregory Brooks and Hylton B. Dupree, Jr. and Blake R. Carl appeared on behalf of the Defendant, Mary Brooks. Also appearing were Marian Weeks, Esq., the Guardian ad Litem and Linda Gettle, Esq., the case mediator.

At the close of mediation, the parties agreed as follows:

1.

CUSTODY & VISITATION/PARENTING TIME

Physical custody of the parties' minor children; to wit: Laura Rawana Brooks, Katherine Mary Brooks and John Stuart Brooks shall remain vested in Plaintiff. Defendant's weekend visitation/parenting time with the minor children, shall be modified and increased to the extent that it shall begin every other Wednesday from the time the children are released from school until Sunday at 6:00 p.m. The beginning date when this

change shall occur is November 17, 2010.

CHILD SUPPORT

2.

The parties agree that child support paid by Defendant to Plaintiff for the benefit of the minor children shall be reduced to Seven Hundred Fifty Dollars (\$750) per month, beginning December 1, 2010, payable in equal installments of Three Hundred Seventy Five Dollars (\$375.00) on the first (1st) and fifteenth (15th) day of each and every month.

ATTORNEY'S FEES

3.

The parties shall be responsible for the payment of their own attorney's fees and expenses of litigation incurred by him or her in connection with this matter. Neither party shall be obligated to pay any attorney's fees or expense incurred by the other and each party hereby waives any and all claims he or she may have against the other for payment of any such attorney's fees.

FULL RELEASE OF ALL PENDING ISSUES

4.

Both parties' acknowledge that this Order resolves all of the pending issues brought in the Plaintiff's Petition and the Defendant's Counterclaim.

THE FINAL JUDGEMENT AND DECREE REMAIN IN EFFECT

5.

All other provisions of the Final Judgment And Decree, Parenting Plain and Child Support Addendum not specifically addressed herein shall remain in full force and effect until such further Order of this Court.
